## PRO-VE 2023 Special Session

### Knowledge Sharing Networks to Support Building a more Sustainable, Fair, and Responsible European Society

#### Scope

The session will put a special emphasis on European values such as sustainability, fairness and responsiveness in relation to collaborative networks which aim to share knowledge, experience, and best practices [knowledge sharing networks]. The session's goal is to investigate how knowledge sharing networks and usage of evolving digital technologies can help to advance interests and freedom of society.

The goal is to create a forum for unique research that examines how knowledge sharing networks improve the ability to collaborate, adapt and co-create value while advancing European values at the same time. We particularly invite papers with a socio-technical focus that integrate organizational, managerial, and technology-related concepts. We encourage empirical contributions, conceptual work, and design-oriented research if they add something original to the conversation. Submissions should consider – but are not limited to – the following aspects:

- The role of knowledge-sharing in achieving EU policy objectives.
- The challenges and opportunities of integrating European values into knowledge sharing networks.
- Case studies of successful knowledge sharing networks that have contributed to EU objectives.
- The future of EU-value based knowledge sharing networks.
- International knowledge sharing networks for European Values improvement.

Acceptance of papers is based on the **full paper** (up to 18 pages). Each paper will be evaluated by three members of the International Program Committee.
